<b>Summary of project (overview of the project idea and requirements)</b>	<p>The project aims to support the health services at Ministry of Health to face Pandemic COVID-19 with estimated cost approximately 500,000 Dollar. As the COVID-19 patients suffer from difficulty in breathing and respiratory problems, the cumulative total of infected Coronavirus cases reached 114,956, according to the daily report of MOH (7<sup>th</sup> July 2021), some critical cases lose their life because of lack of Oxygen. as result the patients need oxygen constantly and continuously . Therefore, the MOH is in need for two (750 liter)O2 Generating Plant for EGH &amp; Shifa hospitals and 130 Oxygen Cylinders (40L) to hospitals and 200 of different size O2 Cylinders for Ambulance devices in order to meet the increasing needs of oxygen supply to patients at some hospital in Gaza Strip as shown:</p>
